Documents submitted on time by bidders shall not be returned.

#### 1.5 LATE BIDS

1.5.1 Bids received late shall not be considered. A bid will be considered late if it arrived only one second after 11h00 or any time thereafter. Bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder with the person delivering the documents. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

- 1.5.2 The official Telkom time (dial 1026) will be used to verify the exact closing time (11h00)
- 1.5.3 Bids sent to SASSETA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the SASSETA premises (tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

The value of this bid is estimated <u>not to exceed</u> R50 000 000 (all applicable taxes included) and therefore the 80/20 system shall be applicable

# Part 9: Technical approach

Bidder must at least:

Describe, in detail, exactly how they propose to carry out the activities to achieve the outcomes identified in the terms of reference. Bidders are required to have the basic office equipment and the resource/s (which must include, laptop, 3G connection, landline, own office with the basic office equipment) will be located within the region where the work will be done. They should identify any possible problems that might hinder delivery and indicate how they will avoid, or overcome such problems.

Describe how the work will be managed. Provide an organisation chart clearly indicating:

- The lines of reporting and supervision within the bidder's team.
- The lines of reporting between the bidder and SASSETA.

Provide a work plan of activities. In addition to providing details of the estimated number of workdays for each activity, bidders are to supply a detailed timetable that identifies when certain activities will be undertaken and over what period they will be spread. The timing of activities, the time needed to complete them, and the order in which they will be undertaken must be explained and justified.

Please note that part 9 should be no longer than 10 single-sided A4 pages in Arial 11 (font size).

### Part 10: Team Details

The bidder must provide:

 Comprehensive curriculum vitae (relevant to this bid and limited to two pages). In particular, the CV must highlight the team member(s) experience and qualifications to carry out the work NB: It is to be noted that team members proposed for this assignment cannot be replaced without prior approval by the SASSETA.

# Part 11: Experience in this field

It is essential the service provider displays:

- Experience as set out in the terms of reference
- The Bidder must provide signed reference letters on company letterheads of previous clients where the Bidder provided similar services.

# Part 12: Bidders National Treasury CSD registration report

Bidders to submit their CSD report indicating the validity of the bidder's registration. Directors listed on SBD 4 to be the same as those listed on the CSD report.

#### 1.8 DUE DILIGENCE - PRESENTATIONS/SITE VISITS

1.8.1 SASSETA reserves the right to request before the award of this Bid. Presentations will only be conducted with bidders who have met the minimum functionality criteria as per phase 2 functionality evaluation.

#### 1.9 NEGOTIATION

- 1.9.1 SASSETA has the right to enter into negotiation with a prospective service provider regarding any terms and conditions, including price(s), of a proposed contract.
- 1.9.2 SASSETA shall not be obliged to accept the lowest of any quotation, offer or bid.
- 1.9.3 SASSETA issues this bid invitation in good faith; however, it reserves the right to:
  - Cancel or delay the selection process at any time, without explanation,
  - Not to select any of the respondents to this bid invitation, without explanation,
  - Exclude certain services, without explanation.
- 1.9.4 All bidders will be informed whether they have been successful or not. A contract will only be deemed to be concluded when reduced to writing in a contract form signed by the designated responsible person of both parties.

### 1.10 REASONS FOR REJECTION

- 1.10.1 SASSETA shall reject a bid for the award of a contract if the recommended bidder has committed a proven corrupt or fraudulent act in competing for the particular contract.
- 1.10.2 SASSETA may disregard the bid of any bidder if that bidder, or any of its directors:
  - 1.10.2.1 have abused the Supply Chain Management systems of SASSETA.
  - 1.10.2.2 have committed proven fraud or any other improper conduct in relation to such systems.
  - 1.10.2.3 have failed to perform on any previous contract and the proof exists.
- 1.10.3 Such actions shall be communicated to the National Treasury.

### 2. TERMS OF REFERENCE

#### 2.1 INTRODUCTION AND BACKGROUND

SASSETA was established on 1 July 2005. It is one of the twenty-one Sector Education and Training Authorities (SETAs) established in terms of the Skills Development Act (Act 97 of 1998) as amended. SASSETA's licence has been renewed until 31<sup>st</sup> March 2020. SASSETA is classified as a schedule 3A Public Entity in terms of the Public Finance Management Act, (Act 1 of 1999, as amended). SASSETA reports to the Department of Higher Education and Training.

#### 2.2 PURPOSE

SASSETA requires a suitable and experienced records management specialist service providers to:

- a) Provide the management of Electronic Records, storage and retrieval;
- b) Provide consultancy services and labour for back scanning and related services
- c) Provide the hosting of electronic records through cloud storage.
- d) Provide maintenance and support services for the above.

In performing the above work the service provider must ensure compliance with the following legislation and other related legal frameworks

- PAIA (Provision of Access to Information Act)
- PAJA (Promotion of Administrative Justice Act)
- PFMA (Public Finance Management Act)
- POPI (Protection of Personal Information)
- Prescription Act
- ECTA (Electronic Communications and Transaction Act)

### 2.3 SCOPE OF WORK

#### 2.3.1. ELECTRONIC RECORDS MANAGEMENT

Provide a system (that will be integrated with the existing system for physical file storage) to create, store, scan and record various physical documents into electronic media. The system needs to be a secure and confidential whereby documents can be created, scanned, indexed and electronically stored and retrieved in a manner that is easily and readily accessible. The system should therefore be able to meet the following minimum requirements

### (i) Functional requirements

- a. Allow receiving and routing of all incoming physical documentation via post or any other means.
- b. Allow tracking of all documentation across the organisation.
- c. Scanning, filing and tracking of all documents to SASSETA
- d. Archiving of such documents
- e. Comprehensive search and find facility

- (ii) Security requirements Access and security The system must have the ability to assign rights and restrictions on the use or management of particular records in order to facilitate security in relation to:
  - a. Access and security controls
  - b. Audit trail
  - c. Disposal
  - d. Disposal authorities
  - e. Disposal application
  - f. Destruction

# (iii) Capturing requirements

Capturing of documents - Capture records regardless of their technical characteristics, so that they can be registered and stored as digital records.

- a) Record types must support the capturing of different record types as defined by the System Administrator.
- b) Record movement allow the re-assignment of records from one folder to another by System Administrator or other authorised user.

# (iv) Classification requirements -

 a) Allow records to be classified in accordance with SASSETA records classification scheme as approved by National Archives and Record Service (NARS) and in line with the Minimum Information Security Standards (MISS).

# (v) Folder Management Requirements

- Allow the addition of digital folders to the lowest levels of a defined records classification scheme, in order to organise aggregations of digital records.
- b) The System must be able to ensure that every folder is allocated to a record category within the records classification scheme.
- c) The system should not limit the number of folders that can be allocated to a record category or defined within the entire system.
- d) The system should be able to generate a sequential numeric or alphanumeric reference for a folder as defined by the approved file plan of SASSETA or allow for the capturing and retrieval of records using different primary and secondary keys.
- e) The system must prevent the destruction or deletion of folders, records and associated metadata at all times, except when authorised to do so by the System Administrator.

### (vi) Searching and retrieval requirements

The system must be able to retrieve digital records and folders by a variety of search and display the results on-screen.

- a) Search function must support the input of user-defined parameters for the purpose of locating, accessing, retrieving and viewing records, folders and other plan entities.
- b) Retrieval must be able to retrieve digital records and folders by all implemented naming principles.
- c) Printing must be able to print all the types of digital records it can capture, without the use of 'screen dumps'.
- d) Metadata must support the use of metadata to describe digital records and to enable automated records management processes.

# (vii) Technical System requirements

- a) The system must be designed to have a user-friendly interface.
- b) The system must be accessible to any computer linked to the SASSETA computer network
- c) Performance must provide a stable and flexible architecture that can grow to meet changing business needs, and continue to meet the record keeping requirements appropriate to its particular implementation. The system must demonstrate acceptable response times for commonly performed functions under normal operating conditions.
- d) Scalability must be capable of controlled growth, to continue to meet anticipated organisational needs over time.
- e) Reliability and control must demonstrate its capacity to remain available and operational, as required to meet business needs. Measures for reliability must include:
- f) Online security must be able to manage digital records which have been subjected to online security procedures, and ensure that such processes do not impair the ability of the Electronic Records Management System (ERMS). Hosting the ERMS must be secured by the SSL (128 Bit)
- g) Users must use a User ID and Password to access the system. Password encryption must be done within MS SQL
- h) Back-Up the system should allow back-up of all data to be done on a daily basis, after business hours

#### 2.3.2. CONSULTANCY SERVICES AND LABOUR

### **Back scanning**

Provide human resource who will scan and upload existing documents

## 2.1. SCOPE OF WORK

The proposed system must support the following, but not limited to the following requirements:

### 2.4 REQUIRED DELIVERABLES

- Fully Implemented Electronic Records Management System to be completed within thirty (30) working days from date of appointment
- Back-scanning of documents to be completed within three (3) month from appointment
- Provision of hosting services for the electronic storage of documents to be completed within thirty (30) working days from the date of appointment
- **Support and Maintenance** on-going from the date of appointment until termination of the contract.
- Training of staff within 14 days after the deployment and 7 days after the major changes on the system and the processes.

# 2.5 SKILLS AND EXPERIENCE OF THE BIDDING COMPANY AND THE TEAM MEMBERS PROPOSED FOR THE ASSIGNMENT

## The bidding Company should demonstrate the following skills and experience:

A minimum of 3 assignments wherein the bidder has successfully implemented an
electronic records management system. A minimum of three (3) signed reference
letters on the letterhead of previous clients and must be relevant to this tender i.e.
a proven track record in the disciplines above and years of appointment (25
points). The reference letters will be used proof of experience.

# The team should demonstrate the experience and skills in the following:

• The team members (minimum of three) to each have a minimum of three (3) assignments undertaken within the field of electronic records management (25 points).

The bidder should indicate which of the team members will be responsible for which components of the work.

#### 2.6 TIMEFRAMES FOR DELIVERY OF THE WORK

The assignment will be from date of inception until 31st March 2020 with an option to renew for a further 24 months depending on the SETA landscape.

#### 2.7 SUBMISSION REQUIREMENTS

The proposal of the bidder is required to consist of, and demonstrate, the following:

- Understanding and experience in the scope of work
- Methodology as to how the scope of work will be executed;
- Project plan as to when various activities will be scheduled and when the deliverables will be submitted; and
- Value add suggestions that will demonstrate the expertise and suitability of the bidder in executing this contract.
- Profile of the bidder;
- Team structure, roles and responsibilities;

- Detailed CVs of all team members:
- Experience of the bidding Company and team related to the skills required and in similar projects successfully undertaken;
- Signed reference letters on an official letterhead from three (3) contactable references demonstrating skills and expertise to undertake the contract

### 2.8 PRICING

### 2.9 ACCOUNTABILITY AND REPORTING

The service provider will report directly to the SASSETA Monitoring and Evaluation Manager for the duration of the assignment.

#### 2.10 INTELLECTUAL PROPERTY

The service provider will be contracting with SASSETA. All products and data of this project, in whatever format raw or analyzed, will be the confidential information for utilization by SASSETA. All information and documents, received from SASSETA or stakeholders, is to be kept confidential and may not be used or distributed in any format without the written approval of SASSETA. To this end, the service provider will be required to sign a confidentiality agreement within the Contract.

## 3. PROPOSED SELECTION CRITERIA

# 3.1. Compliance with minimum requirements

3.1.1. All bids duly lodged will be examined to determine compliance with bidding requirements and conditions. Bids with obvious deviations from the requirements/conditions, will be eliminated from further evaluation.

# 3.2. Conditions for selection/short listing

3.2.1. All submissions will be evaluated as follows:

### 3.2.1.1. Phase 1 - Required items

#### Service Providers to:

- Submit their proposal by the closing date and time. Proposals submitted after the closing date and time will be disqualified from further evaluation.
- Register the proposals in the tender submission register at SASSETA reception. Proposals not recorded on the tender submission register at SASSETA reception will be disqualified from further evaluation.
- complete and submit all Standard Bidding Documents (SBD) forms mentioned above on page 2 of this document, namely: SBD1, SBD3.3, SBD4, SBD 6.1, SBD 8 and SBD 9
- Be registered on the National Treasury Central Supplier Database (CSD) by the closing date and time of this request for quotation. Bidders are to provide SASSETA with a copy of their CSD registration report downloaded from the National Treasury CSD Website.
- Initial each page of the General Condition of Contract (Annexure A) and submit with the proposal

Bidders must meet a minimum functionality points of 70% in order for them to be shortlisted for Phase 3 of this selection process. Bidders who score less than 70% for functionality will be eliminated from further evaluation.

Bidders who score 70% and above for functionality will be shortlisted for phase 3 of the evaluation process which will take place (at SASSETA's discretion) at the Document Storage Facility of the shortlisted bidders in the form a site walk-about and presentation.

Date and time to be confirmed with shortlisted bidder(s). Bidders are to make necessary arrangement to ensure that the proposed sites are available for the site visit.

The Bid Evaluation Committee would conduct presentations.

Should presentations be part of the selection process, functionality will be adjusted to 80% and presentation will be allocated 20%. Total/consolidated points on functionality and Site-visit/presentation must add to 70% or more for a bidder to be shortlisted for phase 4 of the evaluation process. Bidders who score less than 70% after consolidation of functionality and presentation scores will be eliminated from further evalution.

Bidders are required to meet a minimum of 70% for functionality.

## 3.2.1.1.1. Phase 3 – Due Diligence – (Presentation)

Bidders who score 70% and above for functionality will be shortlisted for phase 3 of the evaluation process which may take place (at SASSETA's discretion) in the form of a presentation at SASSETA offices. Date and time to be confirmed with shortlisted bidder(s).

The Bid Evaluation Committee would conduct presentations.

Should presentations be part of the selection process, functionality will be adjusted to 80% and presentation will be allocated 20%. Total/consolidated points on functionality and Site-visit/presentation must add to 70% or more for a bidder to be shortlisted for phase 4 of the evaluation process. Bidders who score less than 70% after consolidation of functionality and presentation scores will be eliminated from further evaluation.

## **3.2.1.1.2.** Phase 4 – Price and B-BBEE
