The Safety and Security Sector Education and Training Authority (SASSETA) is a public entity listed in schedule 3A of the Public Finance Management Act (PFMA) and was established in terms of the Skills Development Act (SDA), Act 97 of 1998. In terms of its function, the SASSETA must perform in accordance with the Skills Development Act, the Skills Development Levies Act (SDLA), the PFMA, any other relevant legislation and the Constitution.
- 1.2. SASSETA's vision is to empower small medium and micro enterprises (SMMEs) by implementing Enterprise and Supplier Development initiatives. These initiatives aim to promote economic transformation through the development of enterprises and suppliers technical, business and management skills.

- 2.2.2.4. How many suppliers/enterprises can be accommodated per initiative
- 2.2.2.5. What is the duration of each initiative
- 2.2.2.6. What is the pricing structure per initiative
- 2.2.2.7. What are the pros/cons of these initiatives if any
- 2.2.2.8. What are the lessons learned from previous implementations
